- Quorum requirements met 20 lot owners present and 5 proxy votes

  - Review of 2023 proposed budget
    - 89% 92% of assessment dues spent on roads, insurance, attorney fees and website.
    - Loan repayment begins in December.
  - 2023 Budget approved unanimously

  - o Audit Committee report Deb Doty reported that all financial data was reviewed and accepted.

- Secretary, Nancy Proctor was replaced by volunteer Carol Venus. All in favor!!
- Open floor to Members/Owners for discussion of any other issues
  - Carol Venus:
    - a) What is the new road going beyond Cooksey's property? Answer/discussion: private property owned by Cooksey's. Not for HROA use.
    - b) Is there any activity regarding the Barnes large "parcel"? No indication of a subdivision is known.
  - Ben Williams: Is there currently an effort to get Spectrum service in the rest of HR?
     Answer/discussion: No, two years ago we approached Spectrum for an installation quote \$78K; not doable!
  - Neil Earnhardt:
    - a) When will the Entry culvert damage be repaired? Answer/discussion: The repair to be completed next week.
    - b) Concern about Quail Ct., Hunters Ridge and their driveway intersection; access/visibility. Is a mirror appropriate? Tom and Nancy volunteered to evaluate the issue.
    - c) Concern regarding trench for power lines alongside Quail Ct. Answer/discussion: EMC will be responsible to repair any damage to the road.
    - d) Renters in lot #8 disturbance of nearby owners:

Discussion: Barking dogs, noise, multiple families in residence reported, kids on motor bikes in street and ATV crash on Worley Cove.

President, David Hudson explained there is no recourse for the Association to pursue; the owner has been contacted many times and has no interest in evicting renters. Secretary, Nancy Proctor had a conversation with the owner last year: he's willing to sell the house and new owner can evict! Q: HOW MUCH DOES HE WANT?? I'll call him and ask.
