

 A lot was accomplished and one thing left undone.

2	Motion to revise 3 drains to 4 and change location (T. Creedon; seconded by F. Schilling; motion passed	В-	 no areas in peril of catastrophic failure ditches still filling four new drains to be installed; 3 were budgeted (2 on Hunters Ridge to replace "bumps"; 2 on Raccoon Pt. due to new pavement). Raccoon, it turns out, doesn't need water diversion. Plan now to replace diverter "bump" with drain above lower Hunters Ridge and Dove Way. (see map) Mr. Norboge negotiated a reduction in fee (\$1800) for water diversion work (to be completed over winter at request of Provider); thanks Michael! Spend to occur from 2017 budget; clearing of ditches planned in exchange
3	Vegetation Maintenance	C+	Big stuff was managed this year; recommendation of 2X a year vegetation cut
4	Entry pavement	Pending	We have not made it all the way to the entrance; some patching was accomplished however (\$4k); Raccoon got asphalted instead (a definite necessity – this work gets an A+)

Plans for 2018 (Roadwork continued)

- \$30K for additional asphalt to complete paving and \$7-9k for gravel; snow removal costs; ditch clearance etc.
- Noted that some improvements will be forever ongoing
- Estimated \$45k annual road costs
